

Entry Rules for the **cadalyst** CADDIES 2004 Mechanical Image Awards

Mechanical/manufacturing entries must arrive by
March 1, 2004

1. Entrants from the United States and Canada only.

2. Complete both pages of the entry form. You must sign and date second page.

3. You may enter a real or imagined project designed in 2003 in only ONE Category and Subject. Do NOT submit entries that you've submitted in previous years. Categories differentiate between professionals, full-time faculty and graduate students, and undergraduate students.

4. You may submit up to three entries total, so long as each is from a different project completed in 2003, but only your top-ranked entry is eligible for an award. Each entry must include a separate entry form and high resolution file and videotape, as required below.

5. Still-image entries: Include a single high-resolution (1600X1280 minimum resolution) image on CD-ROM. Note: We have eliminated animations from the contest.

6. Entry fees. NONE

7. Entries must be at least 80% computer-generated. All computer-generated portions of entries must use CAD (computer-aided design) software in a substantial way. List software you use on entry form.

8. Deadline for entries: All entries must be received at CADALYST's offices by 5:00 p.m.
